In Estonia the sector consists of Eesti Pank, credit institutions, savings and loan associations, and money market funds which fulfill the criteria defined by the European Central Bank. Up to November 2000 monetary aggregates included the deposits of other MFIs (i.e. savings and loan associations and money market funds) with credit institutions and repos. This is due to the reporting rules in force before December 2000.

³ Money on accounts comprises credit institutions' and non-residents' deposits in Estonian kroons held with Eesti Pank.
